When guarding you will prevent accidents and spot potential trouble and intervene before it becomes life-threatening. You will explain safety rules to swimmers and enforce them. You will have a chance to expand your skills and share your passions as all with the goal of improving the quality of life for our citizens. We are looking for dynamic, independent and motivated individuals to join our team, helping us ensure recreation stays safe and fun!

Duties:

- Assist in ensuring that the facility is properly maintained.
- Keep records of every aspect of the pool's operation and maintenance.
- Maintain constant surveillance of patrons in the facility.
- Performs maintenance/janitorial duties, including but not restricted to: change room/washroom cleaning and disinfecting, pool chemistry tests, vacuuming, backwashing, chemical balancing, and pool fouling clean up.
- Ensures that the appropriate equipment is in place and operational and that the equipment is stored away after use.
- Attends mandatory in-house training as required.
- Works in a safe manner at all times in compliance with the Ontario Occupational Safety Act, WHMIS, and Lifesaving Society legislation and internal policy directives and immediately reports all accidents and hazards to a supervisor.
- Executes emergency procedures and uses safety/rescue equipment.
- Perform other related duties as assigned.
- Perform all of the duties as above including lifesaving activities; act immediately and appropriately for the safety of patrons in the event of an emergency.
- Perform all of the duties above including teaching quality swimming programs and providing excellent customer service.
- Provides swimming instruction, skill evaluation, and safety supervision of participants, accident prevention, rescue skills, public education and public relations.
- Plans, conducts and implements safe and educational swimming lessons.
- Performs tasks to support the program including report cards and worksheets.

Requirements:

- These positions requires that the successful applicants are a minimum of 15 years of age in accordance with the Health Protection and Promotion Act, Regulation 565 for Public Pools.
- Current National Lifesaving Service Certification or ability to obtain.
- Current Standard First Aid and CPR qualifications or ability to obtain.
- Current Red Cross Instructor, Lifesaving Instructor Qualification (Instructor Guards) or ability to obtain.

- Able to communicate effectively in English, both verbally and in writing. French language skills are considered an asset.
- Ability to make independent decisions when handling situations involving public emergencies as necessary.
- Upon a conditional offer of employment, a Criminal Record Check.
- Must be capable of meeting the physical demands of the job, including the ability to lift 25 kg (55 lbs.), frequent walking, standing, carrying, and pushing, excellent motor skills, and ability to perform periodic skill testing.
- Must possess the ability and willingness to work in a team setting.
- Must be able and willing to work shifts, weekends, and holidays.
